Course content

The course accentuates above all the history of the English detective story written between 1850 and 1950. Works written by Edgar Allan Poe, Arthur Conan Doyle, Dorothy Sayers and Raymond Chandler and others will be discussed as examples of the genres basic conditions and opportunities. Furthermore a short- story by Jorge Luis Borges will be read to high-light the impact of the detective story on other types of narratives.

Learning outcomes

After having completed the course the student has demonstrated ability to, orally and/or in writing, illustrate and comment on a text in regard to the specific qualities of the genre, that is the Anglo-Saxon detective story and thriller, written between 1850 and 1950.

Education

The form and extent of the education applied, could be adjusted to both the number of the attending students as well as the departments economical situation.

Forms of examination

- a. The examination will be orally or in written form.
- b. Grades are given according to a criterion referenced seven-point scale:
- A = Excellent
- B = Very Good
- C = Good

D = Satisfactory E = Adequate Fx = Insufficient F = Fail

c. The grading criteria for this course are to be distributed at the beginning of the course.

d. In order to obtain at least a grade of E, a student who has received an F or Fx has the right to go through an additional four tests provided the course is still offered. A student who has received a grade of E or higher may not take the test again in order to get a higher grade. A student who has received the grade of Fx or F twice on a given test and by the same examiner can, on application, be granted a new examiner, unless there are specific reasons against it. The application should be addressed to the board of the departmentd. In order to obtain at least a grade of E, a student who has received an F or Fx has the right to go through an additional four tests provided the course is still offered. A student who has received a grade of E or higher may not take the test again in order to get a higher grade. A student who has received the grade of Fx or F twice on a given test and by the same examiner can, on application, be granted a new examiner, unless there are specific reasons against it. Interim

When the course is no longer offered or its contents have been essentially revised, the student has the right to be examined according to this course syllabus once per semester for a three-semester period. However, the restrictions above under 21 d still hold.
