#### Course content

The course gives an overview of the comtemporary political situation of the Korean states with regard to the internal political development as well as foreign policy and the modern economic development, the economic systems, economic geography, the economic policy and planning and foreign trade.

#### Learning outcomes

Having completed the course the student is expected to be able to: -describe the basic features of the political situation in contemporary Nprth and South Korea -describe the basic features of the modern economic development of North and South Korea

#### Education

The method and scope of the teaching is dependent on learning outcomes, the number of students, resources etc. which means that different forms of teaching like lectures, seminars, group work, oral reports etc. may be used. The methods of teaching for the current semester are made available in the course description distributed at the start of the course.

#### Forms of examination

The modules are normally tested with a written examination, but other methods of examination may be used.

The methods of examination are adapted to the learning objectives, group size et cetera of the particular module

and are for the current semester made available in the course syllabus distributed at the start of the course.

Grades are given according to a criterion referenced seven-point scale:

A = Excellent

B = Very Good

C = Good

D = Satisfactory

E = Adequate

Fx = Insufficient

F = Fail

The grading criteria for the course are to be distributed at the beginning of the course.

In order to obtain at least a grade of E, a student who has received an F or Fx has the right to an additional four

tests provided the course is still offered. A student who has received a grade of E or higher may not take the test

again in order to get a higher grade. A student who has received the grade of Fx or F twice on a given test and by

the same examiner can, on application, be granted a new examiner, unless there are specific reasons against it.

The application should be addressed to the board of the department.
