Course content

The module gives a deepened knowledge in theoretical and thematic lines within the area of Latin American Studies. In addition the course presents and examines the interdisciplinary perspective and the theoretical and methodological approaches within some of the social science research perspectives.

Learning outcomes

Having completed the module the student is expected:

- to be able to account for and critically examine different lines within Latin American Studies
- to demonstrate a basic insight in the interdisciplinary method and theory as in some social science research perspective.
- to understand the connection between theory and method
- to have achieved a profound knowledge about one or some research perspective to be able to apply them in their individual project

Education

Lectures and seminars. In the case of low course registration or lack of resources learning will take the form of tutorials or individual tutoring.

Forms of examination

- The course is examined via short papers written for each seminar and a compiled final report.
- Grades are given according to a criterion referenced seven-point scale:
A = Excellent

B= Very Good
C = Good
D = Satisfactory
E = Adequate
Fx = Insufficient
F = Fail

- c. The grading criteria for this course are to be distributed at the beginning of the course.
 - d. A grade of at least E on all modules is required in order to obtain a passing mark for the entire course. A student, who has received a grade of E or higher, may not re-take the test in order to improve his/her mark.
 - e. In order to obtain at least a grade of E, a student who has received an F or Fx has the right to an additional four tests provided the course is still offered.
- A student who has received the grade of Fx or F twice on a given test by the same examiner can, on application, be granted a new examiner, provided there are no specific reasons against it. The application should be addressed to the board of the department.
