#### **Course content**

•Different empirical and theoretical perspectives on poverty and social security allowances

•How poverty and economic marginalisation co-vary with different kinds of socio-political and distribution systems

•Models for working with social security allowances. The administrative and political framework of economic support

•Patterns of duration of economic support and distinctive features with regard to gender, ethnicity and need.

#### Learning outcomes

Upon successful completion of the course students shall be able to:

•give an account of different theoretical and empirical perspectives on poverty

•analyse the significance of social policy and distribution policy for the materialization of poverty and the need for social security allowances

• give an account of how access to and generosity of economic support is affected by different institutional frameworks

•analyse different forms of interventions from a professional viewpoint and in a social policy context •apply knowledge of allowance receiver patterns over time to analyse the varying conditions of different groups.

# Education

Instruction is in the form of lectures and seminars.

# Forms of examination

Examination is by individual oral and/or written assignments.

To pass the course students must have obtained at least grade E on written assignments and actively participated in any other mandatory parts of the course.

Students have the right to request a retake with another examiner if failed twice on a module. Such requests must be made in writing to the director of studies no later than one year after the end of the course.
