Decision

This syllabus has been approved by the Board of the Faculty of Science at Stockholm University.

Prerequisites and special admittance requirements

Admittance to the course requires knowledge equivalent to Cell and Molecular Biology 15 credits, Diversity and Phylogeny of Organisms 15 credits, Physiology 15 credits and Ecology, Floristics and Faunistics 15 credits. (Three credits corresponds to approximately two weeks full-time studies). Swedish upper secondary school course English B or equivalent or one of the following tests. Cambridge CPE och CAE: Pass. IELTS: 6.0 (with no part of the test below 5.0). TOEFL (paper based): 550 (with minimum grade 4 on the written test part). TOEFL (computer based): 213. TOEFL (internet based): 79.

Course content

a. The course covers the following. Contaminations and environmental contamination. How plants function in natural and contaminated areas, including species differences. Plant interactions with land, air and water. Toxicity tests with plants. Mapping of contamination situations using plants. Phytoremediation - the different methods in which plants are used to address pollution problems in the environment.

b. The course includes the following elements: 1. Theory 7.5 hp. 2. Project work 7,5 hp.

Learning outcomes

It is expected that the student after taking the course will be

* able to explain how plants can be used to actually reduce the level of toxic contents, as indicators of contamination and in other pollution-related areas

- * able to use the techniques available in the field
- able to tackle contamination problems by using plants, both theoretically and practically.

Education

The education consists of lectures, group education, laboratory exercises, project work and eventual study visits.

Participation in group education, laboratory exercises, project work and group education associated with this is compulsory. An examiner may rule that a student is not obliged to participate in certain compulsory education if there are special grounds for this after consultation with the relevant teacher.

Forms of examination

- a. Examination for the course is in the following manner: measurement of knowledge takes place through: Written and/or oral examination.
- b. Grading is carried out according to a 7-point scale related to learning objectives:

A = Excellent

B = Very Good

C = Good

D = Satisfactory

E = Sufficient

Fx = Fail

F = Fail

- c. Grading criteria for the course will be distributed at the start of the course.
- d. A minimum grade of E is required to pass the course, together with:
- •approved written and oral presentations
- •participation in all compulsory education.
- e. Students who fail to achieve a pass grade in an ordinary examination have the right to take at least further four examinations, as long as the course is given. The term "examination" here is used to denote also other compulsory elements of the course. Students who have achieved a pass grade on an examination may not retake this examination in order to attempt to achieve a higher grade. Students who have failed to reach a pass grade on two occasions have the right to request that a different teacher be appointed to set the grade of the course. A request for such appointment must be sent to the departmental board.
- f. Students awarded the grade Fx are given the opportunity to improve their grade to E. The examiner decides the supplementary assignments to be performed and the pass mark criteria. The supplementary assignments will take place before the next examination session.

Interim

Students may request that the examination is carried out in accordance with this syllabus even after it has ceased to apply. This right is limited, however, to a maximum of three occasions during a two-year-period after the end of giving the course. A request for such examination must be sent to the departmental board.

Limitations

The course can not be included in a degree together with the course Plants in Environmental Treatment 10 p (BI3860) or the equivalent.

Misc

The course is a component of the Master's Programme in Biology, and it can also be taken as an individual course.

Required reading

Course literature is decided by the departmental board and is described in an appendix to the syllabus.
