Course structure

Course content

This course introduces students to the fundamentals of global political economy. A historical perspective is adopted to bridge the gaps in the intellectual traditions in GPE and provide the necessary conceptual tools to the study of GPE. Accordingly, students will be equipped with deeper understanding of various stages and shifts in the world order beginning in the 1400s and the evolution of GPE theories since the 1700s. The latter half of the course will examine GPE theories in the post-1945 period, and more specifically recent issues in a fast changing global political economy – e.g. trade and liberalization, emerging markets, monetary &

financial system, gender, environment and global governance. Students will be required to critically reflect and apply theoretical tools to pressing issues in the global system.

Learning outcomes

At the end of the course, the student will:

1.possess a deeper historical understanding of GPE and IR theories.

2.be equipped and apply the theoretical/conceptual tools for the analysis of GPE.

3.prepare students for critical scientific investigation and writing skills - i.e. designing, formulating, analyzing and reporting.

Education
