Education

Instruction is in the form of lectures and seminars with active student participation. Certain elements of the course require mandatory attendance and/or written supplementary assignments.

Forms of examination

Attendance at seminars and examinations is mandatory. Grades are given according to the following seventh grade scale:

A= Excellent

B= Very good

C= Good

D= Satisfactory

E= Sufficient

Fx= Fail, minor revisions are required

F= Fail, major revisions is required

Information on grading criteria and forms of examination are communicated at the start of the course.

To pass the course, students must have obtained at least grade E on written assignments and satisfied other demands of the course.

Basis for final course grade:

The final course grade is based on a summation of the grades for each module.

Consequences of getting a fail grade: Getting the Fx or the F grade means that the student must retake the exam at next examination opportunity.

MODULE 1: The Swedish model, 5 credits

Examination with graded ratings: Individual written exam. Other course demands: Mandatory, active participation in seminars.

MODULE 2: Aging and society, 5 credits

Examination with graded ratings: Individual written exam. Other course demands: Mandatory, active participation in seminars.

MODULE 3: Disability and society, 5 credits

Examination with graded ratings: Individual written exam. Other course demands: Mandatory, active participation in seminars.

For information about examination and re- examination regulations, as approved by the Board of the Department of Social Work, see the school website.

Students have the right to request re-examination with another examiner if failed twice. Such requests must be made in writing to the director of studies no later than one year after the course has ended.

Plagiarism, self-plagiarism and other attempts to mislead at examinations or other assessments of study achievement will result in reporting for suspected cheating, which can lead to disciplinary measures.

Limitations

In a final degree, this module may not overlap in terms of knowledge content with any other similar module.

A student who was previously graded in a course with the module MOD1, MOD2, MOD3 or MOD4 will receive instructions on special readings and a special assignment which means a deepening/broadening of the course content and the learning outcomes in MOD4. The student will also receive a certificate including the content of the special examination assignment.
