Course content

This course consists of four course units:

- 1. Linguistic or literary optional course, 7.5 HECs
- 2. Linguistic or literary optional course, 7.5 HECs
- 3. Linguistic or literary optional course, 7.5 HECs
- 4. Linguistic or literary optional course, 7.5 HECs

Learning outcomes

Upon completion of a literary optional course, the student is expected to be able to:

•Give an account of the content of the fictional, critical and theoretical texts included in the selected course;

•Apply literary-critical and other theoretical concepts to literary texts;

•Analyse literary works from a specific theoretical, literary-critical and/or historical perspective, orally and in writing;

•Independently formulate an interpretation of a literary text;

- •Summarise shorter literary-critical texts;
- •Compare different literary-critical or theoretical texts/perspectives;

•Critically evaluate different interpretations of literary texts.

Upon completion of a linguistic optional course, the student is expected to be able to:

•Give an account of the content of the course literature;

•Understand and use basic theoretical concepts, analytical models and methods of the field;

•Apply these concepts to authentic texts or other language material;

•Analyse texts from an appropriate theoretical perspective, orally and in writing;

•Motivate their own analyses in writing and in discussions in a linguistically relevant fashion.

Education

Instruction is generally given in the form of compulsory lectures, workshops, group work and seminars. The form and extent of the training may be adjusted according to the number of students in the course.

Forms of examination

a. The course is assessed as follows:

Course unit 1 - 4

•Written examination and/or written assignments throughout the course

•Assessment of active participation in the seminars

b. For all course components, students will receive letter grades on a seven-point scale related to the learning objectives of the course:

- A = Excellent
- B = Very Good
- C = Good
- D = Satisfactory
- E = Adequate
- Fx = Inadequate
- F = Totally Inadequate

c. The assessment criteria for the course will be distributed at the beginning of the course.

d. In order to pass the course, the grade E or higher is required on all course units. The total course grade will be calculated by weighing the grades from course units 1-4.

e. If students fail a course unit, they are allowed to retake the examination up to four times, as long as the course is still provided. Students who receive a grade of E or higher may not retake the examination to attain a higher grade.

Students who receive the grade Fx or F twice by the same examiner are entitled to have another examiner appointed to determine the grade on the examination, unless there are any specific reasons against it. Such a request should be addressed to the Board of the Department.

f. Attendance to this course is mandatory and a prerequisite for passing.

Interim

If this course is discontinued, or its contents are substantially altered, students have the right to be examined according to this syllabus once per semester for three further semesters. However, the restrictions mentioned above in the forms of examination section still apply.

For comparisons with the previous course system, please refer to the department's student counsellor or director of studies.

Limitations

This course may not be included in a degree together with a course, taken in Sweden or elsewhere, of identical or partially similar content.

If a student has taken the Intermediate course in English/English II, the optional courses may not be identical to course unit 4.
