Course content

The course covers the history of ethology, basic concepts in ethology, learning, ontogeny of behaviour, reproductive behaviour, social behaviour and social organization.

Learning outcomes

It is expected that the student after taking the course will be able to • show basic knowledge in ethology: • show basic skills in studying animal behaviour.

Education

The education consists of lectures, field studies seminars and study visits.

Participation in field studies seminars, study visits

and group education associated with this is compulsory. An examiner may rule that a student is not obliged to participate in certain compulsory education if there are special grounds for this after consultation with the relevant teacher.

Forms of examination

a. Examination for the course is in the following manner: measurement of knowledge takes place through written and/or oral examination.

b. Grading is carried out according to a 7-point scale related to learning objectives:

A = Excellent

B = Very Good

C = Good

D = Satisfactory

E = Sufficient
Fx = Fail
F = Fail

c. Grading criteria for the course will be distributed at the start of the course.

d. A minimum grade of E is required to pass the course, together with:

- approved field studies and participation in all compulsory education

e. Students who fail to achieve a pass grade in an ordinary examination have the right to take at least further four examinations, as long as the course is given. The term “examination” here is used to denote also other compulsory elements of the course. Students who have achieved a pass grade on an examination may not retake this examination in order to attempt to achieve a higher grade. Students who have failed to reach a pass grade on two occasions have the right to request that a different teacher be appointed to set the grade of the course. A request for such appointment must be sent to the departmental board.

Interim

Students may request that the examination is carried out in accordance with this syllabus even after it has ceased to apply. This right is limited, however, to a maximum of three occasions during a two-year-period after the end of giving the course. A request for such examination must be sent to the departmental board.

Limitations

The course can not be included in a degree together with the courses ”Ethology 5 p” (BI6040), ”Ethology 10 p” (BI3040) or the equivalents. A Bachelor degree from the Faculty of Science at Stockholm University may normally include a maximum of 15 hp (ECTS credits) from courses classified as “introductory” courses. Introductory courses may not be included among credits for a Master’s degree at the Faculty of Science, Stockholm University.

Misc

The course includes field studies, which entails additional cost for the student. The course is given as an individual course.

Required reading

Course literature is decided by the departmental board and is described in an appendix to the syllabus.
